1. The Association of Power Utilities of Africa (APUA) has received funding from the African Development Bank Group to cover the cost of the African Network of Centers of Excellence in Electricity (ANCEE) and intends to use part of the grant to finance **the audit of the African Network of Centers of Excellence in Electricity (ANCEE) Centers of Excellence.**
2. The mission provided for under this contract is the functional and organizational audit of the ANCEE centers of excellence in order to have a general assessment of the maintenance of the criteria of excellence of each center of excellence which is a member of RACEE.

The criteria of excellence established at the creation of the network relate mainly to:

- Training activities within the framework of the ANCEE project;
 - Human resources (trainers) of the center of excellence;
 - The infrastructure and means of operation of the center of excellence;
 - The means and tools for communication and promotion of the center of excellence;
 - The financial organization of the center of excellence within the framework of the ANCEE project;
 - The involvement of the center of excellence in the network;
 - The contribution of the Centre of Excellence to the network;
 - The degree of accounting and commercial autonomy of the center.
3. The ANCEE Coordination Unit invites Consultants to apply to provide the services described above. Interested consultants must provide information on their qualifications and experience demonstrating their ability to undertake this assignment (Curriculum vitae, cover letter containing, in particular: documents, reference to similar services, experience in similar assignments, etc.). The expression of interest must also include information on the country of residence and contacts.

The duration of the mission is 2.5 months.
